At Corby Athletic Club, we believe it is everyone's responsibility to ensure the welfare and safety of all those involved in athletics. Most people engaged in the sport do so voluntarily and for the love of athletics, and we are committed to providing a safe, inclusive, and enjoyable environment for all members, regardless of age, background, or ability.

We have adopted and endorse the UK Athletics (UKA) and England Athletics (EA) welfare policies and child protection procedures. These principles are embedded in our own policies, which are available on request. All members, coaches, volunteers, and parents are expected to uphold these standards.

Key Welfare Principles

Safeguarding and Protecting Children

- The welfare and safety of children are always the top priority, ahead of performance or competition.
- Children and young people are encouraged to express their views on matters affecting them.
- Adults working with children must develop appropriate, trusting relationships with athletes, parents, and carers.
- All suspicions or allegations of abuse must be reported to a Welfare Officer and handled appropriately. External agencies such as Social Services, NSPCC, or the Police may become involved.

- Determining whether abuse has occurred is the role of child protection professionals. However, everyone has a responsibility to report concerns.
- Confidentiality must be maintained in accordance with the Data Protection Acts 1984 and 1998 and the common law of confidentiality.

Fairness and Protection of Adults

• Adults working with children must be aware of good practice to protect themselves from wrongful allegations.

Equality and Inclusion

• We are committed to eliminating discrimination and promoting diversity in athletics, regardless of gender, marital status, race, sexual orientation, religion, ethnic origin, nationality, social background, or political belief.

Bullying

• Any form of bullying—physical, emotional, or sexual—is unacceptable. This includes aggression, hostility, or inappropriate behaviour toward fellow members. See our Anti-Bullying Policy for further guidance.

Disciplinary and Grievance Matters

Parents and athletes must be aware of how to raise concerns or make complaints. All matters
will be handled fairly and in accordance with our disciplinary procedures.

Use of Photographic & Video Images

• We adopt good practice guidelines to protect young people from inappropriate use of photographic and video imagery. Consent must be obtained where necessary.

Reporting Safeguarding Concerns

Immediate Danger:

- Call 999.
- Inform a Club Welfare Officer as soon as possible.

Non-Urgent Concerns:

- Do not investigate the issue yourself.
- Record the facts.
- Contact one of the Club Welfare Officers.
